Memories of the Ranaviruwo Musical Show Wasana Bandara

I was at the Cavendish State School, Brisbane on 15th September when the 11 member disabled servicemen's band: "Ranaviruvo", from the Ranaviru Sevena in Ragama, Sri Lanka mesmerized an audience of over 400 spectators by performing the "Ranaviruvo" concert. This event, organized by the Queensland Chapter of the Society for Peace Unity and Human Rights in Sri Lanka (SPUR-Qld), was the third concert held as part of the band's one month tour of Australia and New Zealand. Their performance was amazing, with a wide variety of entertaining music. The musical night started with the band singing songs of tribute to the motherland and Ranaviru Sevena (their rehabilitation centre), leading to powerful patriotic tunes that sent subtle chills and vibes of patriotism amongst the spectators. As the evening progressed, they entertained the audience with authentic Sri Lankan beats ranging from old classics to modern releases, from slow tunes to fast beats, from duets to solos, and many more. The band's extraordinary conduct, pleasing and engaging interaction, and their willingness to cater to the many audience requests, helped them slowly entrap the spectators within an ambiance that

was absolutely entertaining. This was evidenced from the continuous vibrating applauses, the many whistles, and the stamping feet of those who simply could no longer sit in their seats. They rose to dance along in enjoyment, surrendering themselves to the music that these talented musicians created.



The band left the audience in awe and dishelief, when it was revealed

and disbelief, when it was revealed that none of the band members had any music background, until their lives were hit with tragedy. When, in a split second the brutal war seized their ability to be at the forefront of the battlefield to protect us Sri Lankans, these noble men saw a different avenue to reach the nation's citizens. They learnt music in the course of rehabilitation, and used its power to enter the hearts of Mother Lanka's children. With music, they still serve our nation, planting seeds of patriotism and reaching out to Sri Lankans living within and away from their motherland. Their mission is simple - to remind us all of the reality of a ferocious war that has infested the sacred lands of a great country, and to make a humble appeal to help ourselves make the country a true democratic land, which is what they sacrifice their lives, limbs and blood for.

We as citizens of the earth have a responsibility to protect this world. Efficient use of electricity, use of energy efficient vehicles and appliances, use of renewable technology, recycling and planting trees are some of the things we can do.
